## Catering Permit Requirements & Restrictions

Using a catering permit allows for the <u>caterer's staff</u> to pour samples with sizing restrictions.

**Requirements:** 

- All samples served must contain no more than the following:
  - <sup>1</sup>/<sub>4</sub> ounce of distilled spirits (2 ounces mixed cocktails inclusive of <sup>1</sup>/<sub>4</sub> ounce of liquor or <sup>1</sup>/<sub>4</sub> ounce neat pours)
  - 3 ounces for cider, not to exceed a total of 5 ounces
- Formula (if required), COLA (label approval), NY State Price Posting, and NY State Brand Registration
- The caterer must purchase what they serve from a NY wholesaler at the price posted amount

## Marketing Permit Requirements & Restrictions



### **Requirements:**

- All samples served must contain no more than the following:
  - <sup>1</sup>/<sub>4</sub> ounce of distilled spirits (2 ounces mixed cocktails inclusive of <sup>1</sup>/<sub>4</sub> ounce of liquor or <sup>1</sup>/<sub>4</sub> ounce neat pours)
  - 3 ounces for cider, not to exceed a total of 5 ounces
- Formula (if required) and a COLA (label approval)
- All product sampled during the show must be pulled from a NY wholesaler's inventory
